Pursuant to section 3(1) of the Land Drainage Act 1991 ("the 1991 Act")¹, the Natural Resources Body for Wales ("NRW") has prepared the following Scheme making provision for the following matters–

- 1 the alteration of the boundaries of the Afon Conwy Internal Drainage District to exclude the land shown hatched green on the Afon Conwy Map; and
- 2 the alteration of the boundaries of the Ardudwy Marsh Internal Drainage District to exclude the land shown hatched green on the Ardudwy Marsh Map; and

- 3 the alteration of the boundaries of the Glaslyn-Pensyflog Internal Drainage District to exclude the land shown hatched green on the Glaslyn-Pensyflog Map; and
- 4 the alteration of the boundaries of the Gwent Internal Drainage District to-
 - (a) exclude the land shown hatched green on the Gwent Map; and
 - (b) include the land shown hatched blue on the Gwent Map; and
- 5 the alteration of the boundaries of the Harlech and Maentwrog Internal Drainage District to exclude the land shown hatched green on the Harlech and Maentwrog Map; and
- 6 the alteration of the boundaries of the Llanfrothen Internal Drainage District to exclude the land shown hatched green on the Llanfrothen Map; and
- 7 the alteration of the boundaries of the Mawddach and Wnion Internal Drainage District to exclude the land shown hatched green on the Mawddach and Wnion Map; and
- 8 the alteration of the boundaries of the Powysland (Wales) Internal Drainage District to-
 - (a) exclude the land shown hatched green on the Powysland (Wales) Map; and
 - (b) include the land shown hatched blue on the Powysland (Wales) Map; and
- 9 matters supplemental to or consequential on the alteration of boundaries

and NRW submits the Scheme to the Welsh Ministers for confirmation under section 3(5) of the 1991 Act².

² Section 3(5) permits the "relevant minster" to confirm by statutory instrument any scheme submitted. The "relevant minster" is defined in section 72(1) of the 1991 Act as "(c) in relation to internal drainage districts which are wholly in Wales or to the boards for such districts, means the Secretary of State." Functions of the Secretary of State, so far as exercisable in relation to Wales, transferred to the National Assembly for Wales, by the National Assembly for Wales (Transfer of Functions) Order 1999 (SI.1999/672). By virtue of paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c. 32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

2018 SCHEME FOR THE ALTERATION OF BOUNDARIES OF THE AFON CONWY INTERNAL DRAINAGE DISTRICT, THE ARDUDWY MARSH INTERNAL DRAINAGE DISTRICT, THE GLASLYN-PENSYFLOG INTERNAL DRAINAGE DISTRICT, THE GWENT INTERNAL DRAINAGE DISTRICT, THE HARLECH AND MAENTWROG INTERNAL DRAINAGE DISTRICT, THE LLANFROTHEN INTERNAL DRAINAGE DISTRICT, THE MAWDDACH AND WNION INTERNAL DRAINAGE DISTRICT, AND THE POWYSLAND (WALES) INTERNAL DRAINAGE DISTRICT SUBMITTED BY THE NATURAL RESOURCES BODY FOR WALES

- 1 This Scheme shall come into force on the day after the day on which the Order confirming this Scheme is confirmed.
- 2 In this Scheme: -

"the 2013 Order" means The Natural Resources Body for Wales (Functions) Order 2013¹;

"the Afon Conwy Internal Drainage District" means the internal drainage district constituted by The River Conway Drainage Order 1922² as amended by The North West Wales River Board (Transfer of Powers of the River Conway Drainage Board) Order 1953³ and now vested in NRW under the 2013 Order;

"the Afon Conwy Map" means the three maps sealed by NRW dated 31 January 2018 entitled "Afon Conwy Internal Drainage District (IDD) Boundary Review" and deposited at the NRW office;

"the Afon Conwy Removed Land" means such land within the boundary of the Afon Conwy Internal Drainage District as shown hatched green on the Afon Conwy Map comprising lands lying within the communities of Eglwysbach, Trefriw, and Llanddoged and Maenan in the county borough of Conwy;

"the Ardudwy Marsh Internal Drainage District" means the internal drainage district constituted by The Merionethshire Rivers Catchment Board (Ardudwy Marsh Internal Drainage District) Order 1939⁴ as amended and now vested in NRW under the 2013 Order;

"the Ardudwy Marsh Map" means the two maps sealed by NRW dated 31 January 2018 entitled "Ardudwy Marsh Internal Drainage District (IDD) Boundary Review" and deposited at the NRW office;

"the Ardudwy Removed Land" means such land within the boundary of the Ardudwy Marsh Internal Drainage District as shown hatched green on the Ardudwy Marsh Map comprising lands lying within the community of Llanbedr in the county of Gwynedd;

"the commencement date" means the date on which this Scheme comes into force;

"the Glaslyn-Pensyflog Internal Drainage District" means the internal drainage district constituted by The Gwynedd River Board (Glaslyn-Pensyflog Internal Drainage District) Order 1964⁵ and now vested in NRW under the 2013 Order;

"the Glaslyn-Pensyflog Map" means the two maps sealed by NRW dated 31 January 2018 entitled "Glaslyn & Pensyflog Internal Drainage District (IDD) Boundary Review" and deposited at the NRW office;

"the Glaslyn-Pensyflog Removed Land" means such land within the boundary of the Glaslyn-Pensyflog Internal Drainage District as shown hatched green on the Glaslyn-Pensyflog Map comprising lands lying within the community of Porthmadog in the county of Gwynedd;

"the Gwent Added Land" means such land within the boundary of the Gwent Internal Drainage District as shown hatched blue on the Gwent Map comprising lands lying within the communities of Coedkernew in the city of Newport, and Crucorney in the county of Monmouthshire;

"the Gwent Internal Drainage District" means the internal drainage district constituted by the Lower Wye and Caldicot and Wentlooge Internal Drainage Districts (Abolition) Order 2015⁶;

"the Gwent Map" means the six maps sealed by NRW dated 31 January 2018 entitled "Gwent, Caldicot and Wentlooge Sub District Internal Drainage District (IDD) Boundary Review" and "Gwent Internal Drainage District (IDD) Lower Wye Sub District Boundary Review" and deposited at the NRW office;

"the Gwent Removed Land" means such land within the boundary of the Gwent Internal Drainage District as shown hatched green on the Gwent Map comprising lands lying within the communities of Chepstow and Mitchel Troy in the county of Monmouthshire;

"the Harlech and Maentwrog Internal Drainage District" means the internal drainage district constituted by The Merionethshire Rivers Catchment Board (Harlech and Maentwrog Internal Drainage District) Order 1940⁷ as amended by The North West Wales River Board (Transfer of Powers of the Harlech and Maentwrog Internal Drainage Board) Order 1951⁸ and now vested in NRW under the 2013 Order;

"the Harlech and Maentwrog Map" means the five maps sealed by NRW dated 31 January 2018 entitled "Harlech & Maentwrog Internal Drainage District (IDD) Boundary Review" and deposited at the NRW office;

"the Harlech and Maentwrog Removed Land" means such land within the boundary of the Harlech and Maentwrog Internal Drainage District as shown hatched green on the Harlech and Maentwrog Map comprising lands lying within the communities of Ffestiniog, Harlech, Maentwrog, Penrhyndeudraeth, and Talsarnau in the county of Gwynedd;

"the Llanfrothen Internal Drainage District" means the internal drainage district constituted by The Llanfrothen Drainage Order 1928⁹ as amended by The Caernarvonshire Rivers Catchment Board (Llanfrothen Internal Drainage District) Order 1943¹⁰ and The North West Wales River Board (Transfer of Powers of Llanfrothen Internal Drainage Board) Order 1951¹¹ and now vested in NRW under the 2013 Order;

"the Llanfrothen Map" means the two maps sealed by NRW dated 31 January 2018 entitled "Llanfrothen Internal Drainage District (IDD) Boundary Review" and deposited at the NRW office;

"the Llanfrothen Removed Land" means such land within the boundary of the Llanfrothen Internal Drainage District as shown hatched green on the Llanfrothen Map comprising lands lying within the community of Beddgelert in the county of Gwynedd;

"the Mawddach and Wnion Internal Drainage District" means the internal drainage district constituted by The Merionethshire Rivers Catchment Board (Mawddach and Wnion Internal Drainage Board) Order 1947¹² as amended by The Merionethshire Rivers Catchment Board (Reconstitution of the Mawddach and Wnion Internal Drainage Board) Order 1949¹³ and The North West Wales River Board (Transfer of Powers of the Mawddach and Wnion Internal Drainage Board) Order 1950¹⁴ and now vested in NRW under the 2013 Order;

"the Mawddach and Wnion Map" means the two maps sealed by NRW dated 31 January 2018 entitled "Mawddach & Wnion Internal Drainage District (IDD) Boundary Review" and deposited at the NRW office;

"the Mawddach and Wnion Removed Land" means such land within the boundary of the Mawddach and Wnion Internal Drainage District as shown hatched green on the Mawddach and Wnion Map comprising lands lying within the communities of Brithdir and Llanfachreth, Dolgellau, Ganllwyd, and Llanelltyd in the county of Gwynedd;

"NRW" means the Natural Resources Body for Wales as constituted by the Natural Resources Body for Wales (Establishment) Order 2012¹⁵;

"the NRW office" means the offices of NRW at Cambria House, 29 Newport Road, Cardiff CF24 0TP;

"the Powysland (Wales) Added Land" means such land within the boundary of the Powysland (Wales) Internal Drainage District as shown hatched blue on the Powysland (Wales) Map comprising lands lying within the community of Llandysilio in the county of Powys;

"the Powysland (Wales) Internal Drainage District" means the internal drainage district constituted by The Powysland Internal Drainage District (Abolition) Order 2015¹⁶;

"the Powysland (Wales) Map" means the three maps sealed by NRW dated 31 January 2018 entitled "Powysland (Wales) Internal Drainage District (IDD) Boundary Review" and deposited at the NRW office;

"the Powysland (Wales) Removed Land" means such land within the boundary of the Powysland (Wales) Internal Drainage District as shown hatched green on the Powysland (Wales) Map comprising lands lying within the community of Berriew in the county of Powys;

- 3 As from the commencement date, the boundaries of the Afon Conwy Internal Drainage District shall be altered to exclude the Afon Conwy Removed Land.
- 4 As from the commencement date, the boundaries of the Ardudwy Marsh Internal Drainage District shall be altered to exclude the Ardudwy Marsh Removed Land.
- 5 As from the commencement date, the boundaries of the Glaslyn-Pensyflog Internal Drainage District shall be altered to exclude the Glaslyn-Pensyflog Removed Land.
- 6 As from the commencement date, the boundaries of the Gwent Internal Drainage District shall be altered to-
 - (1) exclude the Gwent Removed Land, and
 - (2) include the Gwent Added Land.
- 7 As from the commencement date, the boundaries of the Harlech and Maentwrog Internal Drainage District shall be altered to exclude the Harlech and Maentwrog Removed Land.
- 8 As from the commencement date, the boundaries of the Llanfrothen Internal Drainage District shall be altered to exclude the Llanfrothen Removed Land.
- 9 As from the commencement date, the boundaries of the Mawddach and Wnion Internal Drainage District shall be altered to exclude the Mawddach and Wnion Removed Land.
- 10 As from the commencement date, the boundaries of the Powysland (Wales) Internal Drainage District shall be altered to-
 - (1) exclude the Powysland (Wales) Removed Land; and
 - (2) include the Powysland (Wales) Added Land.
